- 9. Other Issues from the Floor

**Health Department:** Ted had a conversation with Bob White, Wayland code enforcement, who is very involved in lake improvement. In regard to public sewer/water systems at LL. Bob said the Health Department is very much in favor of these improvements and is working in our behalf.

**Lake Tax Assessments:** Tremaine checked on lawsuits pertaining to high tax and found no suits for repayment of over paid taxes.

**Blue Green Algae:** Hilary suggested LLWIA set up a system to alert lake owners when a bloom is sited. Helen reminded us that she or Rod Lindsay should be notified if a bloom is spotted. It was mentioned that not all blooms are not toxic and will usually dissipate in a few days. Also blooms beneath the water surface need not be reported.

**Wetlands:** Darryl has been researching LL wetlands. The area near the weed harvester and Davis road has been identified as federal wetlands. There is much concern for the development on Joe Meyer's property at the south end. Bob White and Darryl are both looking in to this. Floating weed mats can help as substitute mini wetlands.
