## President's comments and updates Eric Busch

-Hunt Sewer Study: follow-up

Eric reports that Hunt felt the meeting was well received.

Hunt went ahead and filed an "Intended to use plan" with the EFC (Environmental Facilities Committee). This was filed in June sometime. Hunt expects to have some feedback in September.

There are grants available from WQIP (Water Quality Improvement Program) through New York State.

Eric B. has proposed a committee to be formed to work on options for a formal petition to the Town of Wayland for a water or sewer district. The committee would represented by LLWIA, LLA, and at large members from around Loon Lake. Eric has asked Bob Reynolds to be on the committee.

There is misinformation regarding the proposal from Hunt. Karen M suggests an FAQ section on the alliance page and also LLA page. Dede suggests adding to the Link for the August delivery. Bob will come up with a hard deadline for Eric and Karen and they will work on the section.

Bridget suggests that it is important for LLA and LLWIA to be united on this plan.

- -Summer Programs: Dede will reschedule Tonal Recall for Saturday August 19th and will bill it as a Picnic at the Pavilion.
- -Emo Road Project: Bob reports that he has reached out to Jeff Parker via his secretary Belinda Parker to discuss. Bob has also spoken to Dale Vargeson who has considered putting another pond for collection of run off.
- -Red Book: Bob reports that he posted online, but is working on getting it downloadable.

### **New Business**

Committee reports:

-Sign Committee: Mark Davidson reports that he has done some research and needs some clarification as to the objective of the signs. He will make a proposal to present for the next meeting. There is already a budget line from 2023 for the signs.

**Preserve Manager report:** Eric Busch offers a thank you to John Hayden for all the weed whacking he has done. He also offered a thank you to Mark Kokanovich for assistance at the preserve.

-Leaning Trees NYSEG: Eric reports that he spoke with NYSEG and the leaning trees have been placed on a 30 day work order. Eric is hoping to have up to seven trees removed to protect lines and the bridge

-Fireworks were a success. No problems noted.

-Junk in the Trunk was a successful venture and a \$110 donation was made from the committee to LLWIA. A thank you was sent to the LLWIA for use of the property.
